Members' Conference 2026 New member offer

TERMS AND CONDITIONS

1. Promoter

This offer is operated by the Royal Academy of Dance, registered at 188 York Road, London, SW11 3JZ ("the Organisation").

2. Offer Summary

2.1 Individuals who purchase an eligible conference ticket for the Members' Conference 2026 taking place 24–26 July 2026 will be eligible to receive six (6) months' free membership of the Organisation, subject to these Terms and Conditions.

2.2 This offer is available on the purchase of any of the following ticket types:

- Three-day in-person pass
- One-day in-person pass
- Online passes
- Bundle passes

2.3 The offer is valid for conference tickets purchased between 11 May 2026 and 26 July 2026 (inclusive).

3. Eligibility

3.1 This offer is open to new members only, defined as individuals who have never previously held membership with the Organisation.

3.2 There are no age restrictions for this offer.

3.3 Only one free membership may be claimed per person.

3.4 This offer may not be available in all countries where the Organisation operates or where membership is managed by local or regional offices.

3.5 Individuals purchasing conference tickets from, or residing in, such regions are advised to **check with their relevant local or regional membership office** to confirm whether this offer is available to them.

3.6 The Organisation reserves the right to determine eligibility for this offer based on regional availability and operational requirements.

4. Membership Categories

4.1 Eligible individuals may be granted one of the following membership categories, subject to assessment:

- RAD Member
- RAD Member Plus
- RAD Registered Teacher

4.2 Membership category will be determined by the Organisation following review of the individual's qualifications and/or experience.

4.3 Acceptance criteria:

- RAD Member: Guaranteed upon application
- RAD Member Plus: Requires a minimum of an intermediate foundation qualification
- RAD Registered Teacher: Applicants must meet the Organisation's eligibility criteria

4.4 All applications remain subject to the Organisation's standard assessment processes.

5. Activation Process

5.1 After purchasing a conference ticket, eligible individuals will be contacted by the Organisation's membership team via email.

5.2 Individuals must:

- Respond to the membership team within 7 days of ticket purchase, and
- Provide all required information to enable membership assessment and setup

5.3 Membership must be fully activated within 30 days of the conference ticket purchase.

5.4 If no response is received, or required information is not provided within this timeframe:

- The offer will lapse, and
- No membership will be created

5.5 Membership will commence from the date it is set up in the Organisation's CRM system.

6. Membership Duration and Renewal

6.1 The free membership period will last for six (6) months from the date of activation.

6.2 Free membership:

- Cannot be paused, extended, or deferred, and
- Is provided for a fixed six-month period only

6.3 Members may request to cancel their membership at any time during the free membership period by contacting the Organisation. Cancellation will take effect from the date confirmed by the Organisation.

6.4 At the end of the six-month period:

- Membership will not automatically renew, and
- Membership will lapse unless renewed by the member

6.5 The Organisation may contact members before the end of the six-month period to:

- Remind them of the upcoming expiry, and
- Provide information about renewal options

6.6 Renewal:

- Will require payment of the applicable full annual membership fee, and
- Will be initiated by the member following receipt of a renewal invitation

6.7 An invoice will be issued for renewal; however, membership will only continue once payment has been received.

6.8 All communications relating to:

- Membership activation

- Administration
- Renewal

will be conducted via email, using the contact details provided by the member.

7. Fees

7.1 This offer covers membership subscription fees only.

7.2 Applicable joining fees may still apply, including (but not limited to) those required for teachers joining via the awarding society route.

7.3 Conference ticket prices are separate from membership and must be paid in accordance with the payment terms selected at the time of booking.

7.4 Where an instalment payment option is selected:

- A minimum of 50% of the ticket price must be paid at the time of booking, and
- The remaining balance must be paid in full by 8 July 2026

7.5 Failure to pay the remaining balance by the stated deadline may result in:

- Cancellation of the conference ticket, and
- Withdrawal of eligibility for the associated membership offer

8. Ticket Cancellation and Event Changes

8.1 If a conference ticket is refunded or cancelled by the purchaser:

- Any associated free membership will be terminated, or
- The individual may choose to continue membership by paying the applicable membership fee from the date of ticket refund

8.2 If the Organisation cancels the conference:

- Eligible individuals will still be granted the full six-month membership period
